The eight deadlines of the Program Responsible Care:

1) Obligations of law and rules

To define and to apply models of behavior and to operate according to the best industrial practices observing all the legislative dispositions.

2) Policies of the firm and documents

To text in favor of all its activities the behavior of the firm regarding Health, Security, Environment and to assure that the Responsible Care Program is clearly felt as part of the policies of the firm.

3) Managing risks

To assure that activities are carried out at conformed levels of security for the benefit of employers, suppliers, customers, public opinion and to safeguard the environment.

4) Emergencies management

To organize and to maintain alive a conformed management system of emergencies.

5) Information

To assure right information related to Health, Security and Environment for products and activities of the firm according to employers, suppliers, customers, authority, public opinion.

6) Training

To assure a non-stop training of all the staff in order to obtain the top level of involvement and engagement in reaching established goals.

7) Non-stop improvement

To support participation to those initiatives improving quality of the activities of the firm and to improve knowledge and awareness towards Health, Security and Environment, being involved in non-stop improvement of its own performances.

8) Interaction with the Community

Pay attention to the local Communities needs and to know them according to the developed activities.
